**CORONA VIRUS**

This directive is applicable to the entire Public Sector: Public Service and all public entities.

This directive shall remain in force until further notice.

In the present circumstances, with measures against the spread of Coronavirus (Covid-19), and in addition to the direction already given by this Office (which is still in place) for requests for teleworking by public officials and public employees to be accepted as far as possible, it is now being directed that, as from next **Monday 8 March 2021**, duties that can be performed by telework are to be shifted thus. All those responsible for managing ministries, departments, entities, and sections should ensure that the presence of public employees in the workplace only occurs when absolutely necessary.

Where the presence of public employees in the workplace is required all necessary steps are to be taken to ensure adherence to the directions in force by the health authorities.

All those responsible for managing ministries, departments, entities and sections should ensure that these measures do not negatively impact the service to Public Sector clients, which should continue to be of high quality.
